Legal Assistance to Military Families

Eligibility

Services under the Legal Assistance to Military Families (LAMS) Project provides civil legal assistance for troops, veterans, family members, or caregivers in the sixteen north Florida counties that LSNF serves whose lives have been impacted by deployment related to the Operation Enduring Freedom (OEF) or Operation Iraqi Freedom (OIF) campaigns.

Legal Services of North Florida serves military personnel and their families who have been, or are now, or are in the process of, going to Iraq or Afghanistan, within 120 days. Priority will be given to those troops who have or will have "boots on the ground".
